THIRD AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF VICTORIA PARK SOHO HOMEOWNERS ASSOCIATION, INC.

- 2. <u>Legal Description of the Property</u>. The legal description of the Property as contained in the Declaration is hereby amended, restated and replaced in its entirety with the legal description

attached to this Third Amendment as Exhibit "A". All references to Property in the Declaration shall mean and refer to the property described on Exhibit "A" to this Third Amendment.

3. Except as modified and amended herein, the terms and provisions of the Declaration as originally executed, and subsequently amended, shall remain in full force and effect, the terms and provisions of which are incorporated herein by this reference. In the event of a conflict between any of the terms and provisions of the Declaration, and any of the terms and provisions of this Third Amendment, the terms and provisions of this Third Amendment shall prevail.
